CITY OF BATAVIA, ILLINOIS WAIVER & RELEASE

IMPORTANT INFORMATION

The City of Batavia is committed to conducting programs and activities in a safe manner and hold the safety of participants in high regard. The City of Batavia continually strives to reduce such risks and insist that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants registering for the Batavia Triathlon and Duathlon Sprint Race must recognize that there are inherent risks of injury when choosing to participate in this competition.

You are solely responsible for determining if you are physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or has recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. Participants of the Batavia Triathlon and Duathlon Sprint Race may be photographed during the event. These images may be used for publicity and marketing.

WARNING OF RISK

The Batavia Triathlon and Duathlon Sprint is intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in this competition. Understandably, not all hazards and dangers can be foreseen. Participants must understand that certain risks, dangers and injuries inherent to swimming, running and bicycling exist. Risks include injury or death due to inclement weather, acts of God, slipping, falling, poor skill level or conditioning, carelessness, unsportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, automobile traffic and intersections, heatstroke, dehydration, cardiac or respiratory arrest, spinal or head/brain injury and drowning. In this regard, it must be recognized that it is impossible for the City of Batavia to guarantee your safety.

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this agreement and release carefully and be aware that in participating in for the Batavia Triathlon and Duathlon Sprint Race, you will be expressly assuming the risk and legal liability, and waiving and releasing all claims for injuries, damages or loss which you might sustain as a result of participating in any and all activities connected or associated with the Batavia Triathlon and Duathlon Sprint Race (including transportation services/vehicle operation, as required).

I am over the age of 18 and legally competent to execute this waiver and release I recognize and acknowledge that there are certain risks of physical injury to participants in this adventure race competition, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that I may sustain as a result of participating in the Batavia Triathlon and Duathlon Sprint Race.
